2. Any person who claims to be entered in this roll and who is not entered therein or is entered in an incorrect place or within incorrect particulars may put in a Claim addressed to the Chief Executive Officer to have his name entered, or the registry corrected, as the case may be.
3. Any person whose name is borne on this roll and who objects to the inclusion of his own name, or that of any other person whose name is on the roll, may prefer the objection addressed to the Chief Executive Officer.
4. Claims shall be preferred in **Form III** and objection in **Form IV** or **Form No. IV-A** appended to this notice and must be signed by the claimant or objector or by his duly authorised agent : copies of the forms will be supplied free by the Chief Executive Officer on application.
5. Claims and objections may be presented to the Chief Executive Officer at any time during office hours or sent by post but it must reach **within twenty days** of the date of issue of this notice (i.e upto **16<sup>th</sup> March 2021**).
6. Claims and objections which are not preferred in the proper form or are not received by the date prescribed will be rejected.
7. All claims and objections received in time and in proper form will be heard by the President or his nominee at Cantonment Board Office, Jalandhar Cantt on **05<sup>th</sup>, 06<sup>th</sup> and 07<sup>th</sup> April 2021 (tentative).**
