It is for information of the General Public of Jalandhar Cantonment that the Central Govt. Min of Defence, New Delhi in exercise of powers conferred under Section 15(1) of the Cantonment Act, 2006, vide SRO 03 (E) dated 17th February,2023 has notified 30th April,2023 as the date on which Ordinary Elections to Jalandhar Cantonment Board, shall be held.

(e) ALLOTMENT OF SYMBOLS TO THE CONTESTING CANDIDATES .

Allotment of symbols to the candidates in the Cantonment Board Elections is regulated by Rule 31(4) of the CER-2007. The Returning Officer to consider the choice of symbols expressed by the contesting candidates in their nomination papers shall be subject to restrictions by the Board and to allot symbols in conformity as far as possible with their choice from the list of symbols enclosed as Annexure-B.

Certain symbols are in use in the elections to the Parliament /Sate legislative. These have been approved by the Election commission of India and have been reserved under the relevant election rules for recognised political parties. However as the symbols of National Parties and State Parties and free Symbols reserved by the Election Commission of India for registered unrecognised political parties cannot be allotted to any contesting candidates of Cantonment Board Elections.

It is desirable that the Returning Officer in their discretion, do not , as far as possible , allot to candidates in Cantonment Board elections the symbols reserved for political parties to avoid embarrassing repercussions, especially since the Returning Officers may be handicapped in the normal course in verifying the bona-fide status of a candidate vis-a-vis the political parties .

The allotment by the Returning Officer, of any symbol, to a candidate shall be final.

The List of Symbols as approved by the Board as Annexure-B is to be Published on JCB website separately.
